## LENGTH OF EXTENDED LIMITED WARRANTY

This Extended Limited Warranty covers the product for parts and labor after the original manufacturer's warranty has expired through the Term of Coverage.

## WHAT IS COVERED/WHAT WE WILL PAY FOR:

When this appliance is installed, operated and maintained according to instructions attached to or furnished with the product, Whirlpool Corporation will provide parts and labor to repair or replace the product at our discretion to correct defects in materials or workmanship in the mechanical or electrical controls. An authorized service company must provide Service.

#### WHAT IS NOT COVERED/WHAT WE WILL NOT PAY FOR:

- A. Service calls to:
  - 1. Correct the installation of your appliance
  - 2. Instruct you how to use your appliance
  - 3. Replace house fuses or correct house wiring
- B. Pickup and delivery. Your appliance is designed to be repaired in the home.
- C. Damage to your appliance caused by accident, misuse, fire, flood, acts of God, or use of products not mentioned in the Use and Care Guide.
- D. The removal and reinstallation of your appliance if it is installed in an inaccessible location or is not installed in accordance with published installation instructions.
- E. Repairs to parts or systems resulting from unauthorized modifications made to the appliance.
- F. Replacement parts for units operated outside the United States.
- G. Repairs when your appliance is used in other than normal, single-family household use.
